APA Style citations consist of two parts: In-text citation: A brief citation in parentheses when you mention a source, citing the author's last name and the year of publication, e.g. (Smith, 2019). It identifies the full source in the reference list.

Primary [unfiltered] and secondary sources cited in your paper must appear in your reference list, using APA 6th edition format. The reference page is considered part of your paper, so the reference section is numbered consecutively (page numbers) as part of your paper.
